The Governor of Haryana is pleased to constitute a committee to search suitable candidates for appointment as Chief Commissioner in the Haryana Right to Service Commission under Haryana Right to Service Act, 2014.

The Search Committee shall comprise of the following:-

(a) Smt. Keshni Anand Arora, IAS Additional Chief Secretary to Govt. Haryana, Revenue Department.

(b) Sh. T.V.S.N. Prasad, IAS Additional Chief Secretary to Govt. Haryana, Finance Department.

Member

(c) Dr. B.K. Kuthiala, Chairperson, Haryana State Higher Education Council

Member

- The Search Committee shall make recommendation to the Statutory Committee as per sub-section (1) of section 13 of the Haryana Right to Service Act, 2014 for appointment of Chief Commissioner pertaining to the Haryana Right to Service Commission.
- 3. The Search Committee shall function subject to the following:-
 - (i) The Chairman and the Member(s) shall enjoy the privilege of being as such till the pleasure of the Government.
 - (ii) The Search Committee of the day shall devise its own principles while arriving at the procedure and criterion adopted by it while making suitable recommendations and furnishing requisite details/materials supporting the suitability of the recommended candidates to be placed before the Committee competent to make recommendations in terms of the Act for its consideration.
 - (iii) The Search Committee may recommend three times as many names as the vacancies to be considered for being filled up.
 - (iv) The Committee competent to make recommendations in terms of the Act shall be at liberty to select as many persons as it deem suitable for being recommended to be appointed as Chief Commissioner out of the recommendations so received from the Search Committee and shall not be bound to make all the requisite recommendations out of the recommendations so received from the Search Committee. The Committee competent to make recommendations in terms of the Act may, if it deems so, shall be at liberty to adopt more or less than the requisite number of vacancy as notified to the Search Committee as fit to be recommended by it for being appointed as Chief Commissioner out of the recommendations received from the Search Committee.
 - (v) The Committee competent to make recommendations in terms of the Act or the Government, may, if it deems it to be fit, require the Search Committee to revisit the principles, procedure and criterion adopted by it and may require the Search Committee to delete, include or vary them as suggested by it and adherence to such suggestions shall be binding on the Search Committee.

- (vi) The Committee competent to make recommendations in terms of the Act or the Government, shall retain the prerogative to forward names of persons to be considered by the Search Committee as candidates in the process of making its recommendations and the Search Committee shall consider all such names on their own merits.
- (vii) The Government shall have the competence to change or vary any/all the conditions constituting these procedures as its discretion and at any time.
- (viii)The Government shall finalize a panel of names, after considering the names submitted by the Search Committee, for consideration of the Statutory Committee. The names, alongwith bio-data and other relevant information, of the persons on the panel shall form part of the agenda forwarded to the members of the Statutory Committee, not less than 7 days, in advance of its meeting.
- (ix) The Office of the Chief Secretary, in Administrative Reforms Department or any other office/officer appointed by the Chief Secretary shall provide Secretarial assistance to the Search Committee.
