

Subject:- Regarding amendment in Financial Assistance policy.

In continuation of this office letter No. 23/1/2005-3D-III dated 24.08.2009, 28.5.2014, 22.9.2015, 29.10.2016 and 21.11.2017 on the subject cited above, it is informed that the State Government has decided to amend the certain eligibility conditions which are as under:-

- (a) An Ex-serviceman who is not in receipt of any Military Pension, Civil Pension or any other Pension or any monthly financial assistance from any State Government/Central Government or any other Constitutional or Statutory Body will be entitled to Financial Assistance at the rate prescribed from time to time on or after attaining the age of 60 years to the date of death provided his annual income from all sources, if any, should not be more than Rs.2,00,000/- (Rupees Two lakh) per annum.
- (b) A widow of deceased Ex-serviceman who is not in receipt of any Pension/Family Pension or any monthly financial assistance from any State Government/Central Government or any other Constitutional or Statutory Body will be entitled to Financial Assistance at the rate prescribed from time to time irrespective of her age upto the date of her death or remarriage whichever is earlier provided her annual income from all sources, if any, should not be more than Rs. 2,00,000/- (Rupees Two lakh) per annum and her marriage had been solemnized after attaining the marriageable age as prescribed under the law.
- (c) All the beneficiaries who avail Financial Assistance shall submit their 'living certificate' and 'income certificate' in their respective office of District Sainik & Ardh Sainik Welfare Department once in every year in the month of November instead of April. The widow shall also give a certificate of Non-Remarriage once in every year in the month of November.
- (d) The Financial Assistance will be admissible from the following month of the month of sanction. No arrear of the past period upto the month of sanction will be admissible.

- (e) If the information regarding death of the beneficiary is given late by the concerned family member, the amount of financial assistance after the date of death would be got recovered from the family member(s)/legal heir(s).
3. All other terms and conditions for grant of Financial Assistance will remain unchanged.
4. This instructions are issued with the concurrence of Finance Department conveyed vide their U.O.No.1/36/2004-1-2FGII/27349 dated 26.9.2019. These will come into force from the date of issue.


