No. 38/1/2000-3Def-II – In supersession of Haryana Government Notification No. No. 38/1/2000-3Def-II, dated 14th October, 2005 the Governor of Haryana is pleased to re-constitute the Haryana Rajya Sainik Board. The functions and the constitution of the Board as under :-

Function of Board

- (a) Co-ordinating the work of Zila Sainik Boards in Haryana State
- (b) Promoting measures for the welfare and resettlement of ex-servicemen and families of serving/deceased personnel of the Armed Forces.
- (c) Disseminating information to the general public regarding the Armed Forces in the country and for taking measures to rouse intelligent interest in the general public.
- (d) Administering the Zila Sainik Boards in the Haryana State in accordance with the rules and instructions prescribed by the Central and State Governments.

The tenure of non-official members will be three years w.e.f. 10th December, 2008.

2. The non-official members of the Board will be entitled to traveling and daily allowances at the rates admissible to Government employees of Grade – I in Haryana except that they will receive only single first class railway fare from the place of their

residence to the place of meeting and vice versa. The non-official members shall also be entitled to perform journey by car and paid road mileage as per Government Rules.
