2. The Fund will be utilized as provided to the Haryana Defence and Security Relief Fund Rules, as amended from time to time.

3. The Committee will formulate its own rules for the transaction of business.

4. The Chairman may convene meetings of the Committee at such place or places as he may deem necessary and convenient for the transaction of business.

5. The Non-official Members of the Committee will be entitled to travelling and daily allowance at the rates admissible to Government employee of Grade-I, except that they will receive only single first class Railway fare, from the place of their residence to the place of meeting and back. The Non-official Members will also be entitled to use their own car at the time of attending the meeting of Haryana Defence and Security Relief Fund Committee and will be paid travelling allowance under Haryana Government T.A. Rules as amended from time to time. The Secretary of the Fund Committee will countersign bills relating to these allowances.

6. A vacancy amongst the members of the Committee from any cause whatsoever will be filled by nomination by the Chief Minister.

7. All contributions and donations will be credited to the Fund, which will be maintained in a Scheduled Bank. The fund will be operated by the Secretary of the Committee.
8. The Deputy Commissioners in Haryana State will be authorized to raise contributions for the Fund.
9. The term of a member of the committee shall be three years.
