

ORDER OF GOVERNOR OF HARYANA

With reference to Government of India letter No. A-19014/1/95/MF.CGA/Gr.A/Per/SD/712, dated 11.06.2019, Government of Haryana is agreed to appoint Ms. Sofia Dahiya, ICAS-1994, as Advisor in the Finance Department for two years. 
