I am directed to refer to the instructions of Haryana Government issued vide letter No. 12/8/03-4GSII, dated 06-06-2003 on the subject noted above wherein it was conveyed that the Ex-servicemen who had availed the benefit of re-employment in any Government service, Public Sector Undertakings, including Para Military Forces, their dependent sons and daughters will not be considered for appointment (s) against the posts reserved for ex-servicemen.

- 2. On reconsideration of the matter, State Government has decided that the Exservicemen who had not availed the benefit of **ESM** in re-employment in any Government Service, Public Sector Undertaking, including Para Military Forces, their dependent sons and daughters will be considered for appointment (s) against the posts reserved for Exservicemen to the extent of non availability of suitable ex-servicemen, provided they fulfill all the required conditions viz qualifications, age, experience etc.. This entitlement would be available to one dependent child only.
