Subject:- Ex-gratia grant and other facilities to the families of Government employees who die while in service- waiving of recovery of loans from employees belonging to Group-C and D(Class-III and Class IV).


Sir,

I am directed to invite your kind attention towards state Government letter No. 16/49/2009-6GSII dated 16-8-2010 on the subject noted above, wherein it was decided to extend the facility of waiving off the recovery of outstanding principal amount of House Building advance, Marriage advance, Wheat advance, Festival advance, Cycle advance, Plot loan and interest thereon due from deceased Govt. Employee of Group C&D, who dies while in service. However, the outstanding principal amount of HBA and Plot loan will be waived off only in those cases where not more than one surviving members of the family of deceased Govt. employee is employed. On further consideration of the matter, it has now been decided to extend this facility of waiving off recovery of balance outstanding principal amount of Computer Advance and interest thereon due from Govt. class III and IV employee, who dies while in service on the same terms and conditions mentioned in above letter.

2. These instructions shall come into operation with immediate effect and shall not have retrospective effect.

3. This issues with the concurrence of the Finance Department Vide their U.O. No. 36/1/2010-WM (4), dated 22.6.2010 and even No. dated 21/23.10.2013.


