No. 27/1/1998 -3GS-II It is hereby notified that 11th, 15th, 19th, 23rd, 27th February, 2017, 4th and 8th March 2017 the days of poll for the General Elections to Uttar Pradesh and 15th February, 2017 day of poll for General Elections to Uttarakhand Legislative Assembly shall be observed as paid holiday/special casual leave (paid) in all Government of Haryana offices, Educational Institutions, Boards and Corporations under Section 25 of the Negotiable Instrument Act, 1881 and under Section 135-B of the Representation of the People Act, 1951 (amended in 8/1996) in respect of those employees of the State Government who are registered voters of Uttar Pradesh and Uttarakhand for casting their votes in the said Elections on the respective dates.


It is also notified that the employees of various factories, shops and private establishments located in Haryana, who are registered voters of Uttar Pradesh and Uttarakhand are also allowed to take leave (paid) under Section 135-B of the Representation of the People Act, 1951 (amended in 8/1996) for the same purpose.
