**Subject: - Payment of wages of persons engaged under part-I of Outsourcing policy through cashless mode**

Sir/Madam,

I am directed to refer to the Government letter No.43/5/2001-3GSII dated 20/2/2014 and 43/5/2001-3GSII dated 2-6-2014 on the subject cited above and to say that vide letter No. 16/7/2015-3GSII dated 11/9/2017 the Government had decided to increase the wages /honorarium of Contractual /outsourced persons engaged under Part –I of outsourcing policy dated 06.04.2015, w.e.f. 01.01.2016.

Wages in case of Part I shall be as under:-

Sr. No.	Type of Service	Pre-revised Rate	Revised Rate
1.	Unskilled persons	8100/-	9258/-
2.	Semi skilled persons	9000/-	10286/-
3.	Skilled persons	10000/-	11429/-
4.	Highly Skilled persons	11000/-	12572/-

\*Note: Existing wage multiplied by 14.29 percent.

2. Further the Govt. has decided that the provisions of mode of payment of wages mentioned in clause- iii of the guidelines of payment of wages issued vide Government letter No. 43/5/2001-3GSII dated 20/2/2014 and the provisions of Government letter dated 2/6/2014 regarding mode of payments of wages as prescribed plus other benefits like ESI, EPF etc, to the above categories of workers appointed in the state Government Departments as well as its Boards and Corporations and Local Bodies engaged under part-I of

outsourcing policy dated 6/4/2015 are substituted by the following provisions: -

“that the agency will make payment of wages as prescribed plus other benefits like ESI, EPF etc. per month to the above categories of workers appointed under the provisions of Part-I of Outsourcing Policy in the state Government Departments as well as its Boards and Corporations and Local Bodies only by way of Account Payee through a cashless mode like RTGS, Electronic Wallets etc. No payment shall be made through cheque /cash / bank draft .”

3. It is made clear that the other terms and conditions of the letters under reference shall continue.
