No. 11/02/2018-3GS-II-It is informed that bye-Elections to **02-Kairana Parliamentary Constituency of Uttar Pradesh, 2018** shall be held on Monday, the 28th May, 2018.

In terms of powers conferred under Section 25 of the Negotiable Instruments Act, 1881 and Section 135-B of the Representation of the people Act, 1951 (amended in 8/1996) it is hereby declared that the day of poll shall be observed as paid holiday, casual leave (paid) in all Government of Haryana offices, Educational Institutions, Boards, Corporations of Government of Haryana in respect of those persons who are registered voters in 02-Kairana Parliamentary Constituency of Uttar Pradesh.


It is also notified that the employees of various factories, shops and private establishments located in Haryana, who are registered voters of 02-Kairana Parliamentary Constituency of Uttar Pradesh are allowed to take leave (paid) 135-B of the Representation of the people Act, 1951 (amended in 8/1996) for this purpose. The employers of those establishments in State of Haryana, whose workers are registered voters in 02-Kairana Parliamentary Constituency of Uttar Pradesh are directed to grant their employees and daily wagers/casual workers paid holiday on the date fixed for the poll i.e. 28.5.2018 (Monday).
