Table of benefits for the savings fund for the period from 01-04-2016 to  
31-03-2017.**

I am directed to invite your attention to Haryana Government letter No.4/3/97-3NGIS dated 15-4-2015, on the subject noted above. The tables of benefits for the saving fund of the scheme based on a subscription of Rs. 10/- per month from 01-04-1986 to 31-12-1989 and Rs. 15/- per month w.e.f.01-01-1990 onwards have been prepared for the year 2016-2017 and a copy of the same is enclosed. Another table of benefits for the saving fund based on a subscription of Rs. 10/- per month for those employees who had opted out of the revised rates of subscription w.e.f. 01-01-1990 have also been drawn up for the year 2016-2017 and a copy of the same is also enclosed for your guidance and compliance thereof. The amount in the tables have been worked out on the basis of interest @ 8.7% per annum (compounded quarterly), as notified by Government of India. The mortality rate under the scheme has been taken as 3.75 per thousand per annum up to 31.12.87 and 3.60 per thousand per annum thereafter in both cases. While calculating the amounting it has been assumed that the subscription has been recovered or will be recovered from the salary of the month in which a member ceases to be in service failing which it should be deducted from accumulated amounts payable.
