Subject:- Standard Terms and Conditions for appointment of non-officials as Chairmen and Deputy/Vice Chairmen in Bodies other than PSUs, Statutory Commissions and Constitutional Bodies of Haryana.


Sir/Madam,

I am directed to refer to the subject noted above and to say that the Standard Terms & Conditions issued vide Govt. letter No. 36/5/2006-4 Pol. dated 18-11-2017 have been reconsidered by the Government and it has been decided to substitute the Item (i) of the Clause (2) Honorarium of the Standard Terms & Conditions of Non-officials who are appointed as Chairmen in Bodies other than PSUs, Statutory Commissions and Constitutional Bodies of Haryana which is as under:-

<p><u>Honorarium</u></p> <p>(i) <u>Chairman</u></p> <p>Honorarium may be allowed at such monthly rate as may be determined by the concerned Department, but not exceeding Rs.50,000/- (Rupees fifty thousand only) per month subject to the condition that if an MLA is appointed as Chairman, the total emoluments admissible under these instructions and any other rules/instructions as an MLA, shall not exceed the total emoluments admissible to a Minister at any point of time.</p>	<p><u>Honorarium</u></p> <p>(i) <u>Chairman</u></p> <p>Honorarium of Chairman of Boards/Corporations as contained in Clause (2) of the Standard Terms & Conditions issued vide No. 36/5/2006-4 Pol, dated 18.11.2017 be enhanced from Rs. 50,000/- (Rupees fifty thousand only) per month to Rs. 75,000/- (Rupees seventy five thousand only) per month subject to the condition that if an MLA is appointed as Chairman, the total emoluments admissible under these instructions and any other rules/instructions as an MLA, shall not exceed the total emoluments admissible to a Minister at any point of time.</p>

2. This issues with the concurrence of the Finance Department conveyed vide their No. 8136/HBPE(FD) dated 26.03.2019. These shall come into force with immediate effect.
