In the Haryana Government, General Administration Department (Protocol Branch), notification No. 16/27/2017-4Protocol, dated 16th April, 2018 the following amendment are made:-

Para 4 (b) amended as :

“4 (b) Emergency sufferers, getting pension or honorarium of any kind from any other State Government will also be eligible. Thus, getting pension from any other State Government would not be a bar for entitlement of pension to an otherwise eligible person under the scheme.”
