

It is proposed to fill up the post of Chief Controller in the Vikram Sarabhai Space Centre, (VSSC), Thiruvananthapuram, of this Department in the HAG Scale of ₹67000-79000/- on deputation basis. The pay and other conditions of service of the selected Officer will be regulated in accordance with DoPT OM No.2/29/91-Estt.(Pay-II) dated January 05, 1994, as amended from time to time.

2. Chief Controller will be the administrative Head of Vikram Sarabhai Space Centre (VSSC), Thiruvananthapuram, which is the largest Centre of Indian Space Research Organisation (ISRO) having a manpower strength of about 5000 employees.
