Subject: Recruitment in HCS (Executive Branch) from Register C of District Development and Panchayats Officers/ Block Development and Panchayats Officers under rule 14 of Haryana Civil Service (Executive Branch) Rules, 2008 against the vacancies of the year 2012.

Will the Principal Secretary to Government Haryana, Development and Panchayats Department kindly refer to the subject noted above?

**2.** He is informed that it has been decided to fill up two vacancies of HCS (Executive Branch) from Register C of District Development and Panchayats Officers/ Block Development and Panchayats Officers against the vacancies of the year 2012 in terms of rule 14 of Haryana Civil Service (Executive Branch) Rules, 2008. He is, therefore requested to send a list of eligible District Development and Panchayats Officers/ Block Development and Panchayats Officers of not more than five times of the number of vacancies as per rules for the aforesaid recruitment.

**3.** The officers whose names are to be recommended should fulfil the following conditions of eligibility as on **1.1.2014:-**

- i) has completed eight years continuous Government service;
- ii) has not attained the age of forty eight years;
- iii) is not facing disciplinary proceedings against whom action is being contemplated ; and
- iv) is clear from vigilance angle;
- v) is a graduate of a recognised University.

**4.** The department shall follow the instructions of Chief Secretary, Haryana issued vide endorsement no. 46/1/2013- 5 SII dated 10<sup>th</sup> May, 2013 and name (s) of the meritorious candidates shall be forwarded to the Chief Secretary to Government, Haryana. While making recommendations, the following record/information may also be forwarded:-

- i) Service profile of the eligible officer in proforma 'I' (five copies).
- ii) The upto date ACRs in original, of the officer concerned.
- iii) Attested copies of summaries of ACRs from the year 2003-2004 to 2012-2013 in Form 'II' (five copies).
- iv) Integrity certificate in Form 'III' (five copies).

**5.** He is requested to send the recommendations by **15<sup>th</sup> October, 2013** **positively**. Recommendations received after this date will not be entertained/considered.
