**SUBJECT:- REVISION OF PENSION/FAMILY PENSION OF PRE-2016 IAS
PENSIONERS IN TERMS OF GOI LETTER DATED 12.05.2017.**

Sir,

I am directed to refer to GOI's letter dated 12.05.2017 and Haryana Govt. letter No. 10/11/2017-4SIII dated 10.08.2017, vide which the pension/ family pension of pre-2016 IAS (Retd.) officers is to be revised. The matter regarding revision of pension/family pension has been examined by this office and 126 cases in respect of revision of pension/family pension have been considered and all these cases have been sent to the Principal Accountant General, Haryana Chandigarh to issue the revised PPO (List at Annexure-I).

Further, 49 cases have been examined by this office and calculation of pension/family pension has been made in accordance with the GOI letter dated 06.07.2017. However, these cases could not be sent to the Principal Accountant General, Haryana Chandigarh as the information regarding pension/family pension as on 01.01.2016 according to 7th CPC, has not yet been received from the Pension Disbursing Cell of Finance Department/Banks (Annexure-II).

Besides, in respect of 84 cases at Annexure-III and 21 cases at Annexure-IV, no record is available in this office. As such, without any record, the matter of revision of pension/family pension could not be examined.

Therefore, to expedite the process of re-fixation of the remaining cases of pension/family pension, all the IAS officers (Retd.) or family pensioners, as the case may be, listed in Annexure II,III&IV are requested to provide the following information to Personnel Department (in Services-III Branch) through mail id (suptdservicesIII@gmail.com) at an early date:-

1. **For those listed in Annexure II**
 - (i) Authentic copy of Bank statement, indicating the basic pension/family pension as on 01.01.2016 in the 7th CPC.
 - (ii) Name of the family pensioner, where applicable, with the copy of latest PPO.
2. **For those listed in Annexures III&IV**
 - (i) Last promotion orders.
 - (ii) Retirement orders.
 - (ii) Last Pay Certificate.
 - (iv) Copy of latest PPO
 - (v) Name of the family pensioners, where applicable, with the copy of latest PPO.

Pensioners/Family Pensioners who draw their pension form Government of India are not required to provide the above information.
