

## ORDER

GEETA BHARTI, IAS** for attending the 119<sup>th</sup> Induction Training Programme for IAS officers (Promoted or on the select list) to be conducted at Lal Bahadur Shastri National Academy of Administration, Mussoorie from **03.07.2017 to 11.08.2017** on the following terms and conditions:-

- (a) That they will be treated as on duty for the period of the training programme and permissible journey days as provided in item I ( i ) of the schedule under Rule 2.16 (b) of the Punjab CSR Vol. I Part. I read with Note 3 below Rule 8.1 of the said rule.
- (b) That they will be paid Traveling Allowance/Daily Allowance as admissible under Rule 2.88 of the Punjab CSR Vol.III (TA Rules) read with the Instructions contained in Haryana Govt. Finance Department, Circular letter No.5/6(ii) /3FR-I dated 9.1.81.
- (c) That all the expenditure on this training programme in respect of above mentioned officers regarding pay and allowances, TA/DA etc. will be met by the State Govt. ( in their respective Department) from the same head of account from where the officer drew their pay before proceeding to this training course.
- (d) 'Official (white) passport (which is valid for at least 6 months from 15.08.2017 onwards) is necessary for all the prospective participants for training portion abroad.

2. Sanction of the Governor of Haryana is also accorded to the grant of **₹ 3,75,000/-** (Rupees Three Lac Seventy Five Thousand only) to every IAS officer to meet the expenditure during the period of training to be conducted by the Academy from 03.07.2017 to 11.08.2017 as detailed below:-
