In exercise of the powers conferred by Rule 45 of the Fundamental Rules and all other powers enabling him in this behalf, the Administrator, Union Territory, Chandigarh, hereby makes the following Rules further to amend the "Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996" namely :-

1. (i) These Rules may be called "The Government Residences (Chandigarh Administration General Pool) Allotment (Amendment) Rules, 2025".

(ii) They shall come into force from the date of their publication in the Chandigarh Administration Gazette.

2. In the "Government Residences (Chandigarh Administration General pool) Allotment Rules, 1996" (hereinafter referred to as the 'Rules'), the following para of sub-rule-3 of Rule 6 of said Rules, 1996 shall stand deleted:-

"H.E. the Administrator, Union Territory, Chandigarh, vide order dated 22.6.2020 has allowed two months retention of Transit Accommodation on transfer/retirement of the allottee".

In the "Government Residences (Chandigarh Administration General Pool) Allotment Rules, 1996" (hereinafter referred to as the 'Rules'), below the existing explanation given under the table of sub-rule (2) of Rule 13 of said Rules, 1996, a new explanation shall be added as under:-

"Explanation- The permissible period of retention of residence as provided against event 1 and 2 given under the table of sub-rule (2) of Rule 13 of said Rules shall also be applicable in case of Transit Accommodation allotted under Rule 6 of the said Rules".
