In the case the Chairman/Chairperson of the Committee is unable to chair the meeting in any calendar month, then the Vice-Chairman, i.e. the Deputy Commissioner of the district (concerned) shall chair the meeting on behalf of the Chairman on the last working day of the month, to ensure that a meeting of the District Public Relations and Grievances Committee is held every month and the meeting of the District Development and Monitoring Committee is held as per necessity.

4. The Vice-Chairperson, i.e. Deputy Commissioner of the district (concerned) are requested to bring this to the attention of all members as well.
