ORDER

The Governor of Haryana is pleased to constitute a Committee comprising the following officers to regularly monitor the progress of development works in the State and to avoid delays in their execution. The Committee shall review the progress of development works on a fortnightly basis. The progress shall also be reviewed at the level of the Hon'ble Chief Minister, preferably once in two months. The Committee shall consist of:

1. **Dr. Saket Kumar, IAS – APSCM**
2. **Sh. Narender Pal Malik, HCS – OSD/CM**
3. **Sh. Karan Ahlawadi, Sr. Consultant to CM**

Further, Sh. Rajeev Batish, Chief Engineer, Public Health & Incharge, shall provide technical assistance related to the HEWP Portal for review purposes.

The committee will look into the following aspects:

- Timelines from administrative approval to award of work.
- Delays in architectural approvals after administrative approval/conceptualization of the project.
- Time taken between award and commencement of work including the permission required from other departments.
- Timely completion of awarded projects.
- Reasons for delay and cost escalation, if any.
- Revised timelines after a revised administrative approval, whenever applicable.
- Completion of work within prescribed/revised timelines.
- Maintenance of assets created.

The Committee will also apprise the PSCM about the progress achieved in this regard on a monthly basis.
