Subject:- Regarding filling up of backlog of Scheduled Castes and Backward Classes in the service of Haryana Government/Public Sector Undertakings/Universities etc. in accordance with the direction of Hon'ble Punjab and Haryana High Court in CWP No. 3042 of 2012.

Sir/Madam

I am directed to refer to the subject noted above and to state that the matter regarding filling up the vacancies pertaining to the backlog of Scheduled Castes and Backward Classes categories has been under consideration of the Government for some time past. As per information received from the Welfare of Scheduled Castes and Backward Classes Department, there is a huge backlog of the posts meant for Scheduled Castes and Backward Classes categories in various Departments. Hon'ble Punjab and Haryana High Court in CWP No. 3042 of 2012-Rajesh Kumar Vs. State of Haryana has directed to take immediate steps to fill up the said backlog.

2. Accordingly, the matter has been considered and it has been decided that the backlog of Class-III and Class-IV vacancies in respect of Scheduled Castes and Backward Classes categories needs to be addressed urgently by invoking special measures. You are, therefore, requested to work-out the number of vacancies of these categories as on 31.03.2013. Thereafter, each department would notify the vacancies and invite applications from the eligible candidates for

recruitment. After scrutinizing the applications as per the prescribed eligibility criterion, they would shortlist the eligible candidates on the basis of their marks in the qualifying examination as prescribed under their service rules subject to the maximum number of five times the number of notified vacancies. A common Selection Committee would be constituted by the Government (separately) to interview all the shortlisted candidates and recommend suitable names for appointment. You are, therefore, requested to take action in the matter in a time-bound manner and intimate the General Administration Department accordingly.
