



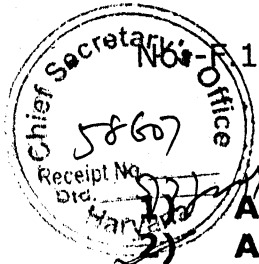

Sub: Regarding sponsoring the names for appointment to the post of Deputy Commissioner on deputation basis in MCD.

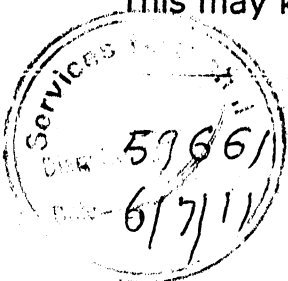
Sir/Madam,

I am directed to communicate that few vacancies of Dy. Commissioners are anticipated in near future, in the pay scale of Rs.14300-18300/-(pre-revised), which are required to be filled up on deputation basis in MCD. As per notified RRs to the post, **Officers of the IAS with 11 years' service as such or officers of Central Services Group 'A' with 5 years' service in posts in the scale of Rs.12000-16500/-(pre-revised) or equivalent are eligible for the post.** (Period of deputation, including the period of deputation, in another ex-cadre post held immediately preceding this appointment in the same organization/department shall not exceed 5 years').

MCD follows the Rules/Regulations/Instructions of the Govt. of India and therefore the laid down terms and conditions of deputation of the Govt. of India shall be applicable *mutatis mutandis* to the officer on deputation basis. The pay scale mentioned above are pre-revised hence officer in the corresponding Grade Pay/ Pay Band as prescribed in the VIth CPC would be eligible for the post.

It is, therefore, requested that the names of suitable and willing officers alongwith their application, bio-data, ACRs for the preceding five (5) years, Integrity Certificate, Vigilance Clearance and Cadre Clearance etc. may kindly be forwarded, within 60 days, to enable us to consider selection for appointment to the above said posts on deputation basis.

This may kindly be given **TOP PRIORITY.**
