  - (e) Ability to co-ordinate with various agencies such as State Governments, the Law and Order authorities, different agencies of Central Government such as customs, Railway, Ministry of Labour etc.
  - (f) Experience and ability in personnel management and understanding of establishment matters.

3. Officers belonging to All India Services (IAS/IPS/IFS) and Central Services Group 'A', who have put in not less than 20 years of service in Group 'A' are eligible to be considered for this post. Preference may be given to those having experience of working in Port and Shipping sector. The pay scale and other terms and conditions of appointment of the officers selected, shall
