The Government of India has enacted the National Green Tribunal (NGT) Act, 2010 (19 of 2010) for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources including enforcement of any legal right relating to environment and giving relief and compensation for damages to persons and property and for matters connected therewith or incidental thereto. As per Section 3 of the NGT Act, the Central Government has established the National Green Tribunal. Member (Judicial): A person shall not be qualified for the appointment as a Judicial Member of the Tribunal unless he is, or has been (a) a Judge of the Supreme Court of India; or (b) Judge of the High Court.

- (a) has a degree in Master of Sciences (in physical sciences or life sciences) with a Doctorate degree or Master of Engineering or Master of Technology and has an experience of 15 (fifteen) years in the relevant field including 5 (five) years practical experience in the field of environment and forests (including pollution control, hazardous substance management, environment impact assessment, climate change management, biological diversity management and forest conservation) in a reputed National level institution; or
- (b) has administrative experience of 15 (fifteen) years including experience of 5 (five) years in dealing with environment matters in the Central or a State Government or in reputed national or State level institution.

A Member of the Tribunal, either Judicial or Expert, who has at least four years clear term from the last date of submission of the applications would be given preference.

*Term of office:

(i) A Judicial Member of the National Green Tribunal shall hold office for a term of 5 (five) years from the date on which he join his office.

Provided that in case a person, who is or has been a judge of the Supreme Court, has been appointed as Judicial Member of the Tribunal, he shall not hold office after he has attained the age of 70 (seventy) years.

Provided further that in case a person, who is or has been the Chief Justice of a High Court, is appointed as Judicial Member of the Tribunal, he shall not hold office after attaining the age of 67 (sixty-seven) years.

Provided further that in case of a person, who is or has been a Judge of a High court, is appointed as Judicial Member of the Tribunal, he shall not hold office after attaining the age of 67(sixty- seven) years.

(ii) An Expert Member of the National Green Tribunal shall hold office for a term of 5 (five) years from the date on which he enters upon his office or until he attains the age of 65 (sixty-five) years, whichever is earlier.

* Salary & Allowances and other conditions of service

Salary and allowances:

(i) the Judicial Member shall be entitled to a monthly salary of Rs. 80,000/- (Eighty Thousand) (fixed) and to such allowances as are admissible to a sitting judge of a High Court; and

(ii) the Expert Member shall be entitled to a monthly salary of Rs. 80,000/- (Eighty Thousand) (fixed) and to such allowances as are admissible to a Secretary to the Government of India:

Provided that in case a person appointed as a Member, is drawing any pension, the pay of such person shall be reduced by the gross amount of pension drawn by him.

Provided further that a Member shall be entitled to draw allowances on the original basic pay, before such fixation of pay.

*House Rent Allowance:

A Judicial Member or an Expert Member shall have the option of claiming house rent allowance at the rate of 30% (thirty percent) of the basic pay drawn:

Provided that he shall not be eligible for House Rent Allowance in case he is provided with a Government accommodation.

*Eligible and interested persons may submit their applications in the prescribed format (Annexure-1) to Shri Vivek Wadekar, Director, Room No. 103, Paryavaran Bhawan, CGO Complex, Lodi Road, New Delhi-110003 on or before 5th September, 2011.
