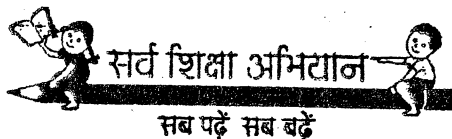
**Office Memorandum**

**Subject: Filling up of the post of Member (Technical) in the Pay Band-4 (Rs.37400 – 67000) + Grade Pay of Rs.10,000 in Inland Waterways Authority of India (IWAI), NOIDA (UP) on deputation basis.**

It is proposed to fill up the post of Member (Technical) in Inland Waterways Authority of India (IWAI), Noida (UP) by transfer on deputation basis. The post is in the Pay Band-4 (Rs.37400 – 67000) + Grade Pay of Rs.10,000. The term of office is 3 years and can be extended up to 5 years.

2. Member (Technical), Inland Waterways Authority of India will be responsible for :-

- Investigation, planning and formulation of projects and execution of water fronts and waterways structures and maintenance of infrastructure facilities on national waterways for shipping and navigation.
- Carrying out river conservancy works and river training works for safety and convenience of shipping and navigation on national waterways.
- Implementation of traffic regulations on national waterways and supervision of navigation, hydrographic surveys etc.
- Organizing and conducting studies/surveys on national waterways and other potential waterways.
- Rendering technical advice and expertise to the Authority.
- Any other responsibility assigned by the Chairman.



- (g) He will be a full-time **Member** of the Authority and will report to the Vice-Chairman of the Authority.

3. As a Member of the Authority, Member (Technical) will be entitled for free unfurnished accommodation on deduction of 10 percent of the salary subject to the ceiling on the **monthly** rentals for such accommodation to be regulated in accordance with the rules for the time being in force for allotment of residence or to draw such house rent allowance as is admissible to the highest category of officers of the Authority.

4. The applicants fulfilling the following eligibility criteria may apply :-

- (i) **Age:** Not exceeding 57 years on the closing date of receipt of application (Age limit will not be applicable in case of departmental candidates);
- (ii) **Term:** 3 years, extendable up to 5 years.
- (iii) **Qualifications and Experience:**

**Essential Qualifications:** Bachelor's Degree in Civil Engineering/Technology from a recognized university. Preference will be given to an applicant having post graduate degree in any discipline of Civil Engineering (i.e. Water Resources Engineering, Irrigation Engineering etc.);

**Experience:** At least 10 years experience in planning, investigation, designing and execution of waterfront structures out of which at least 3 years should be in the PB-4 (Rs.37400-67000) plus Grade Pay of Rs.8700 (pre-revised pay scale of Rs.14,300-18,300/- or equivalent) and above;


- (iv) **Desirable:** The applicant should be well-versed in infrastructure creation, maintenance and contract management. The applicant should also have fair knowledge of river conservancy and river training works for safety and convenience of shipping and navigation. Experience in barge operations, lock/ship lift operations, dredging operations, navigational aids and hydrographic surveys etc. would also be desirable.


