



Dear Ms. Gulati,

Telecom Regulatory Authority of India (TRAI), having its Headquarter in New Delhi, is established through an Act of Parliament in 1997, to regulate the Telecommunications Service and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters therewith or incidental thereto. TRAI has also been entrusted with the mandate of regulating of Broadcasting and Cable Services w.e.f. 2004.

Over the years, the telecommunication sector in India has attained a tremendous growth and approximately one third of the total subscribers are in rural areas. In order to achieve the mandate entrusted to TRAI in the changing scenario, it has been decided to open regional offices at Guwahati, Kolkata, Patna, Lucknow, Bhopal, Chandigarh, Jaipur, Mumbai, Hyderabad and Bangalore. A circular inviting applications from eligible officers has been issued on 19th October, 2011 with last date for receipt of applications is 11th November, 2011 for filling up the posts in these offices on deputation basis (copy enclosed).

I shall be grateful if you could give wide publicity amongst the officers belonging to All India Services/Central Govt Services working in your state and forward applications of eligible and willing officers to us for consideration for appointment to the posts mentioned in the vacancy circular.

Sub:- Calling applications for filling up of various posts on deputation on foreign service terms.

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The Organization proposes to fill up various posts on deputation on foreign service terms initially for a period of two years in its regional offices to be opened shortly which would be located in various state capitals. 3. Essential Qualification for (Sr No. 1, 2 & 3):- A Master/Bachelor's Degree in Business Administration / Economics/ Commerce/ Engineering/ Law/ Science/ Humanities from a recognized University/ Institution or Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field.

Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) officers in twelve years of regular service in Group A of which at least four years of regular service shall be in the Junior Administrative Grade and possessing essential qualifications shall be considered for appointment as Joint Advisor in the Pay Band - 4 of Rs. 37400 - 67000 + GP Rs. 8700.
5. The posts of Advisor & Deputy Advisor/Joint Advisor have been exempted upto 23.1.2016 and the posts of SRO and Assistant have been exempted upto 23.5.2013 from the rule of immediate absorption by Department of Pension & Pensioners Welfare for appointment of central govt., servants on deputation.
