

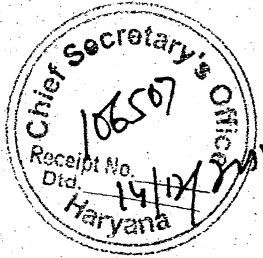

This is in continuation of this office letter no. 2882 dated 16.12.2010 and its subsequent reminder No. 560 dated 10.03.2011 vide which Delhi Development Authority had invited applications to fill up a few posts of Director (Ministerial) in Pay Band-3 i.e. Rs. 15600-39100/- with Grade Pay Rs. 7600/-, on transfer on deputation basis initially for a period of one year extendable up to five years on year to year basis, from suitable officers belonging to Central/State Government holding analogous posts or officers with five years of service in the PB-3 i.e. 15600-39100/- with grade Pay Rs. 6600/-.
