It is headed by a Chairman with the status of Ex-officio Secretary to the Govt. of India. The post carries a fixed pay of Rs. 80,000/- (revised) (Rs.26000/- pre-revised). The post of Chairman, CWC is likely to fall vacant w.e.f. 1.8.2012.

- 2. It is proposed to fill up the post of Chairman, Central Water Commission by deputation of officers under the Central Government / State Governments / Union Territories and fulfilling the following eligibility criteria: -
