

Dear Sir,

This is regarding posting of a substitute in place of Smt. Neerja Sekhar, IAS (HY:93), Director, Census Operations, Haryana who has since been relieved on her appointment as Director in the Department of Justice under Ministry of Law and Justice for the balance period of her Central Deputation tenure i.e. upto 30-05-2014.
