

I am directed to say that it is proposed to fill up the post of Director General in the Narcotics Control Bureau (NCB) under the Ministry of Home Affairs on deputation basis in the scale of pay of Rs. 22,400 - 525 - 24,500/- w.e.f. 01.08.2012. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization / Department of the Central Government shall ordinarily not exceed five years. The maximum age for appointment on deputation shall not exceed 56 years, as on the closing date of application.

2. As per the Recruitment Rules, the post is to be filled up from amongst officers of All India Service and officers of other Group 'A' Central Services.
