

Gallery, Chandigarh on deputation.

Sir,

I am directed to address you on the subject noted above and to inform that a post of Director, Government Museum and Art Gallery, Union Territory, Chandigarh in the revised pay scale of Rs. 15600-39100 + Rs. 6600/- Grade Pay is lying vacant. It has been decided by this Administration to fill up this post by taking an officer on deputation. It is, therefore, requested to kindly send a panel of suitable officers of the age not exceeding 56 years as on the closing date of the receipt of application, who are willing to serve in this Administration on deputation basis and who possess the following qualifications and experience, to this Administration within two months, positively :-

(a) **Officers of the Central/State Governments/Union Territories :-**

- (i) Holding analogous post on regular basis in the Parent Cadre/Department; or
- (ii) With five years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 15600-39100 + Rs. 6600/- Grade Pay or equivalent in the parent cadre/Department; and

(b) **Possessing the following educational qualifications and experience :-**

- (i) Master's Degree in Indian History/Archaeology/Anthropology/Fine Arts from a recognized University or equivalent.
- (ii) Diploma in Museology with four years experience in a Museum of Standing in a responsible capacity including Administrative experience of one year.

OR

Six years experience in a Museum of Standing in a responsible capacity including one year Administrative experience.

Note 1: Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note 2: The qualification (s) regarding experience is/are relaxable at the discretion of the Union Public Service commission, in case of candidates belonging to Scheduled Castes or Scheduled Tribes, if at any stage of selection the Union Public Service commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

Desirable :

- i) Experience of research in the relevant areas with evidence of published work in Technical Journals.
- ii) Knowledge of Indian Antiquities/Archaeology/Museums/Publications/India Arts and Decorative Art.

(The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion).

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/ Department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications).

The eligible officers should apply for the aforesaid post and also forward their applications through their respective departments. While forwarding the applications of the eligible officers, the concerned department should furnish the following certificates alongwith the application/bio-data of officer so recommended :-

- i) Integrity Certificate/Clearance.
- ii) Vigilance Certificate/Clearance.
- iii) Statement of major/minor penalty, if any, imposed upon the officer during last ten years.
- iv) ACR Dossiers (in original).
