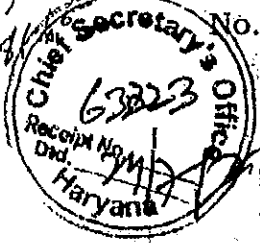

East Delhi Municipal Corporation intends to fill the following vacancies through deputation:-

1. Chief Architect: No. of vacancies - 1 (One)

Pay Band & Grade Pay: PB - 4 (Rs.37400 - 67000) + Grade Pay Rs.10000

Eligibility conditions for Deputation:

Officers of Central/State/UT/Govt. Services (Group 'A')-

- (i) Holding analogous post on regular basis in the parent cadre/department OR
- (ii) With 5 years' regular service in the scale of Rs. 37400 - 67000 + GP - Rs.8700 in a post immediately subordinate to the post at (i) above in the parent cadre/department and having the following educational qualifications and experience:-

Essential:

- (i) Degree in architecture from a recognised University or equivalent.
- (ii) 15 years' experience in the profession.
- (iii) Should be registered with the council of Architecture.

Desirable:

- (iii) Fellowship of the Indian Institute of Architects or equivalent membership of a professional institute.

1. Qualifications are relaxable at the discretion of the UPSC in case of candidates otherwise well qualified.

The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC in the case of candidates belonging to Scheduled Castes and Scheduled Tribes if, at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.
3. The departmental officers in the direct line of promotion will not be considered for deputation and likewise officers on deputation will not be considered for promotion.
