

Sir/Madam,

This is regarding filling up of the post of General Manager [NEF], Food Corporation of India, Shillong under the Department of Food & Public Distribution.

- Officers of the rank of Deputy Secretary/Director of the Government of India or equivalent level, eligible for appointment under the Central Staffing Scheme are eligible for the post. The period of deputation is 4/5 years for Dy. Secretary/Director respectively.
- The General Manager[NEF], FCI, Shillong is primarily responsible for maintaining supply of food grains under PDS; managing other welfare schemes of GOI and managing operational issues relating to storage, movement, sales, quality control etc. The selected officers will require to deal with personnel and labour related issues, co-ordinate and continuously liaise with the State Government.
- The post may be circulated amongst officers eligible to be appointed at Deputy Secretary/Director or equivalent level in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded to the Department along with **cadre clearance, vigilance clearance, detailed bio-data in the enclosed proforma and CR Dossier**. For officers working in the cadre, it may also be ensured that the 'Cooling off', after a previous stint on deputation, if any, is completed and the officer is eligible to be appointed on Central Deputation as per instructions.

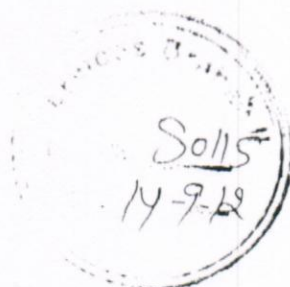
