



Please refer to this office letter of even no./3043 dated 21.08.2012 vide which it was requested to sponsor the names of suitable willing officers of CSS/State Civil Services Officers to fill up the vacant posts of Deputy Director (Ministerial) in DDA on deputation basis, in Pay Band-3 i.e. Rs. 15600-39100/- With Grade Pay Rs. 6600/- for a period of one year which is extendable up to five years on year to year basis, officers belonging to Central/State Government holding analogous posts or officers with five years of service in the PB-3 i.e. 15600-39100/- with grade Pay Rs. 5400/- or officers with 8 years service in the PB-2 i.e. 9300-34800/- with Grade Pay Rs. 4800/- are eligible for the post of Deputy Director (Ministerial).
