The Kerala State Electricity Regulatory Commission (KSERC) has been created by the Government of Kerala under the provisions of the Electricity Act, 2003. The Commission consists of a Chairperson and two Members. The post of Chairperson of the Commission became vacant, consequent on the demise of Shri. K.J. Mathew on 11.09.2012.

2.
