The undersigned is directed to say that in terms of section 6 of the Prevention of Money Laundering Act, 2002, the Central Government has established an adjudicating Authority at New Delhi to exercise jurisdiction, powers and authority conferred by or under the said Act.

Two posts of Members, in the Pay Band - (Rs.37400-67000) plus Grade Pay of Rs.10,000 with usual allowances as are admissible to a Group 'A' officer of the equivalent grade, are to be filled up - one each from the following fields:-

From the field of Law

A person shall be qualified for appointment as Member from the field of law, if

In terms of the provisions contained in PMLA, one of the Members of the Adjudicating Authority shall be appointed as its Chairperson in the pay scale of [HAG - Rs.67000 - (annual increment @3%) - 79000] with usual allowances as are admissible to a Group 'A' officer of the equivalent grade. The pay of Chairperson or Member shall be fixed in terms of the instructions of the Government issued in this regard.
