- TAMP is an Autonomous Statutory Body set up under Major Port Trusts Act, 1963 to fix and revise tariffs in Major Ports with a view to provide a level playing field for port operators including Major Ports and Private Operators. The Member assists the authority in the conduct of its business and in convening the meetings. He/she will be in charge of analysis of various tariff cases, to be presented before the Authority for its consideration. He/she may also be required to handle the affairs of the Authority as assigned from time to time in absence of the Chairman.
