

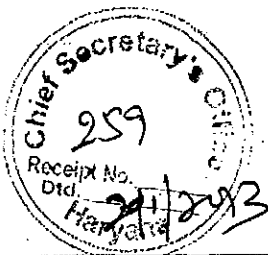

1. Assessor & Collector

No. of posts: 01

Pay Band + Grade Pay: Pay Band 4 + Grade Pay Rs.8900

Eligibility conditions: Officers of Indian Administrative Service/Central/State Govt./UTs.

- Holding analogous posts on a regular basis in the parent cadre/department or
- With 2 year's regular service in the grade rendered after appointment thereto on regular basis in Pay Band 4 Rs.37400-67000 + Grade Pay Rs.8700 or equivalent in the parent cadre/department, or
- With 6 years regular service in the grade rendered after appointment thereto on regular basis in Pay Band 3 Rs.15600-39100 + Grade Pay Rs.7600 or equivalent in the parent cadre/department.
- Possessing 12 years experience including 5 years in Revenue related work.

2. Since, the North DMC follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable *mutatis mutandis* to the officer on deputation basis in North DMC. Further, the maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
