Sir,

I am directed to state that it is proposed to fill up the post of Secretary in the Bureau of 3 Energy Efficiency on deputation basis from the officers of Central or State Governments holding a post not below the rank of Deputy Secretary to the Government of India in the parent cadre.

The post of Secretary in the Bureau of Energy Efficiency (BEE) carries the scale of pay of PB-4 Rs. 37400-67000 + Grade Pay of Rs. 8,700 (pre-revised Rs. 14,300-18,300). The officer selected for appointment will be entitled to draw pay/deputation allowance + other allowances as per Central Government Rules.
