

Dear Sir,

Ministry of Development of North Eastern Region (MoDoNER) is mandated to take up special developmental concerns of North Eastern States and is implementing World Bank funded livelihood promotion project for rural poor in four States of Tripura, Sikkim, Nagaland and Mizoram. North East Rural Livelihood Project (NERLP) under this Ministry is being implemented through an autonomous registered society, namely; North East Livelihood Promotion Society located at Guwahati. The Project Director is Chief Executive of the Society.

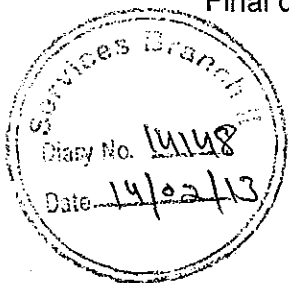
2. Post of Project Director who is Member Secretary of Executive Committee is required to be filled up. This Ministry is notifying for a suitable person fulfilling the criteria mentioned below. Selection of the officer will be done as per extant guidelines of Department of Personnel and Training for posts under non-central staffing scheme through a search-cum-selection committee. Tenure of Project Director will be for five years or as may be decided by Govt of India. The eligibility criteria are:

13-2-13(a) Project Director appointment shall be for a period not exceeding 5 years or as may be decided by the Govt of India.

(b) Project Director shall be a senior officer from All India Services/Organized Gr 'A' Services in the rank of Joint Secretary/Director to the Govt of India. Officers of provincial services of North Eastern States may be considered in case they fulfil the requirements. While making appointment from AIS/Organized Gr A services, Central Govt may also simultaneously explore direct recruitment mode for selection of Project Director from persons fulfilling following conditions;

- (i) Having educational qualification of at least graduation.
- (ii) Should not be less than 45 years or more than 62 years on the day of application.
- (iii) Work experience in Developmental projects in some senior managerial capacity.
- (iv) Persons having experience in Financial and HRD management.
- (v) Person should have sufficient knowledge of culture/economic and social aspects of NER.

Final decision regarding appointment /recruitment will rest with MoDoNER.

(c) Project Director will be appointed by Central Govt as per extant Service Rules of AIS/Organized Gr 'A' Service as per applicable guidelines of Department of Personnel and Training, Govt of India. However, in event of Central Govt going in for direct recruitment, candidates who apply for post may be shortlisted by a Committee constituted by MoDoNER. Shortlisted candidate may be subjected to interview by another Committee, constituted by MoDoNER.

4. You are requested to circulate this among officers of the IAS/AIS working in your Ministry/State Government and other affiliated organizations and institutions. Application with complete bio-data may be sent by 25th Feb 2013 to the undersigned.
