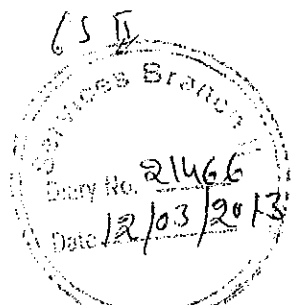
I am directed to address you on the subject cited above and to state that

Government.


It is therefore requested to circulate the vacancy and send the
