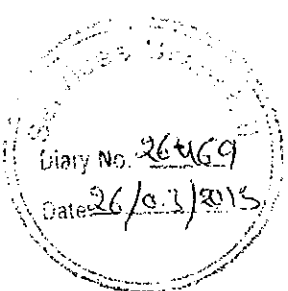

**NOTIFICATION CALLING FOR NOMINATIONS FOR  
APPOINTMENT OF CHAIRMAN OF THE ANDHRA PRADESH  
ELECTRICITY REGULATORY COMMISSION.**

The Andhra Pradesh Electricity Regulatory Commission has been constituted in the month of April, 1999 with Chairman and two Members to regulate the electricity Industry in Andhra Pradesh to act in an efficient economic, safe and transparent manner. The term of present Chairman is completing on 24-04-2013. Accordingly, it is decided to call for nominations from suitable persons to fill up the post of Chairman of the A.P. Electricity Regulatory Commission after completion of term of the present Chairman. The appointment would be made in accordance with the following:-

- 1) The Member shall have Graduate qualification with specialization and adequate experience in any of the disciplines like Law, Economics, Commerce, Finance, Accountancy or Administration.
- 2) The minimum age limit for appointment is 55 years. Maximum age of the eligible candidates is 62 years. The tenure of the Member appointed will be Maximum of 5 years or till he attains the age of 65 years, which ever is earlier.
2. As per Andhra Pradesh Electricity Regulatory Commission (conditions of service of Chairman & Member) Rules 1999, the pay and allowances of the Chairman of the Commission shall not be inferior to the pay and allowance paid to Chief Justice of Andhra Pradesh High Court.
3. Interested candidates may send their representations with following details :
  - 1) Bio-data of proposed candidate containing the following details:-
    - a) Name
    - b) Age & Date of Birth
    - c) Position now held
    - d) Educational Qualification
    - e) Details of posts previously held and experience in any of the field of Law, Economics, Commerce, Finance, Accountancy or Administration
  - 2) Willingness letter to resign his / her present post and to join APERC, if selected.
  - 3) A letter intimating the details of any office, employment or consultancy agreement or arrangement which he/she has in his / her own name or in any firm, association of persons or body corporate, or in the names of any relative, carrying on any of the following business, namely:-
    - i) generation, transmission, distribution or supply of electricity

- ii) manufacture, sale or supply of any fuel for generation of electricity.
- iii) manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity and
- iv) any entity providing professional services to any of the businesses referred to in sub-clauses (i), (ii) and (iii) above.

4. The nominations as indicated above are to be sent to the following address. The last date for receipt of nominations is **12-04-2013**.
