

Subject : Filling up the post of Special Director of Enforcement in the Directorate of Enforcement on deputation basis - Regarding.

Sir,

I am directed to inform that The Ministry of Finance (Department of Revenue) has invited the nominations for the post of Special Director of Enforcement in the Directorate of Enforcement at Kolkata in PB-4 of Rs.37400-67000/- with Grade Pay of Rs. 10,000/- {Rs. 18400-500-22400/- (pre-revised)} on deputation basis. The following categories of officers are eligible:-

I. Officers of All India Services/Central Services / Central Bureau of Investigation:-

- (a) (i) Holding analogous post on regular basis in the parent cadre/department; or
- (ii) holding Selection Grade in PB-4 of Rs. 37400-67000/- with Grade Pay of Rs. 8700 {Rs.14,300-400-18,300} pre-revised of the Junior administrative grade with three years regular service in the grade or above; and
- (b) Possessing experience of at least fifteen years in the field of Intelligence, Investigation and Adjudication/Prosecution work relating to Fiscal/Criminal Laws.

II. The Departmental Additional Directors of Enforcement in PB-4 of Rs. 37,400-67,000/- with Grade Pay of Rs. 8700/- {(Rs.14,300-18,300) pre-revised} with three years regular service in the grade on the last date of calling for application for deputation shall also be considered alongwith the outsiders and in case anyone is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

2. The State Governments are, therefore, requested to sponsor the names of willing and eligible IPS officers who are empanelled to hold IG level posts at the Centre. While nominating the names of officers it may also please be confirmed that the officers are clear from vigilance angle, their integrity certified and they have completed the required 'cooling off' period wherever applicable.
