

11 3-4-13 2. Officers of the rank of Deputy Secretary/Director of the Government of India or equivalent level, eligible for appointment under the Central Staffing Scheme are eligible for the post. The period of deputation is 4/5 years for Dy. Secretary/Director respectively.

DSA 3. The General Manager [J&K], FCI, Jammu is primarily responsible for maintaining supply of food grains under PDS; managing other welfare schemes of GOI and managing operational issues relating to storage, movement, sales, quality control etc. The selected officers will require to deal with personnel and labour related issues, co-ordinate and continuously liaise with the State Government.
