

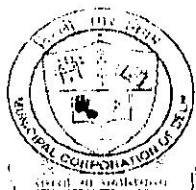

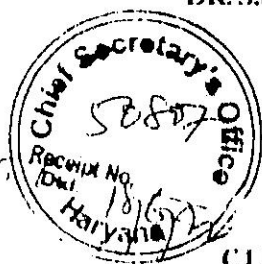

Eligibility conditions: Officers from the Central/State Govts.

- (i) Holding analogous posts on a regular basis or
- (ii) With 2 year's regular service in the grade rendered after appointment thereto on regular basis in Pay Band 4 Rs.37400-67000 + Grade Pay Rs.8700 or equivalent in the parent cadre/department, or
- (iii) With 6 years regular service in the grade rendered after appointment thereto on regular basis in Pay Band 3 Rs.15600-39100 + Grade Pay Rs.7600 or equivalent in the parent cadre/department.

b) Educational Qualifications

Essential:-

- 1) M.Sc in Agriculture with specialisation in Horticulture/M.Sc in Horticulture (including Floriculture, Olericulture etc.) from a recognised University or equivalent.

Eligibility conditions: Officers from the Central/UTs.

(i) Holding analogous posts on regular basis or

(ii) With 5 year's regular service in posts in the Pay Band 3 Rs.15600-39100 + Grade Pay Rs.6600 or equivalent, or

(iii) With 10 years regular service in posts in the Pay Band 2 Rs.9300-34800 + Grade Pay Rs.5400 or equivalent.

b) Educational Qualifications

Essential:-

1) Diploma in Printing Technology from a recognized Institution University or equivalent.

2) 10 years practical experience in Printing, including 2 years administrative experience.

Since, the North DMC follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable *mutatis mutandis* to the officer on deputation basis in North DMC. Further, the maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
