

The post of Chief Vigilance Officer (CVO) is to be filled by the Panjab University, Chandigarh in the Pay Band of Rs. 37400-67000/- + G.P. Rs. 8900/- on deputation basis by considering officers from Central Services. The initial deputation tenure would be of 3 years which is extendable up to a further period of 2 years (total 5 years). The pay of the person appointed on deputation will be protected and he/she will be eligible for the applicable deputation allowance.

The Chief Vigilance Officer is to advise the Vice-Chancellor on vigilance complaints concerning the University Officers, staff & teachers and to ensure probity and integrity in Public Administration with the following objectives:-

1. to get expedited the disposal of cases under investigation with the CBI/Courts,
2. to activate the vigilance machinery in the University for investigating complaints,
3. to sensitize the University community against corruption and corrupt practices,
4. to strengthen preventive vigilance by streamlining procedures, and
5. to prevent the possibilities of corruption and encourage a culture of honesty and integrity.

You are requested to provide us a panel of suitable eligible persons for their selection/appointment on deputation as Chief Vigilance Officer.
