I am directed to inform you that, the Andhra Pradesh Electricity Regulatory Commission has been constituted in the month of April, 1999 with Chairman and two Members to regulate the electricity Industry in Andhra Pradesh to act in an efficient economic, safe and transparent manner. The Member, APERC is retiring on **13-08-2013** and it is decided to fill up the said post. The Selection Committee for this purpose has been constituted vide G.O.Ms.No.20, Energy Department Dt.06-03-2013 as per Section 85 (1) of Electricity Act, 2003.

I am directed to invite proposals and nominations of suitable persons for consideration of the Selection Committee for the post of Member of the A.P. Electricity Regulatory Commission. The nominees should be persons of ability, integrity and standing with adequate knowledge or experience of, or should have shown capacity in dealing with problems relating to Economics, Commerce, Finance, Accountancy, Law or Administration. The appointment would be made in accordance with the following:-

- 1) The Member shall have Graduate qualification with specialization and adequate experience in any of the disciplines like Law, Economics, Commerce, Finance, Accountancy or Administration.
- 2) The minimum age limit for appointment is 55 years. Maximum age of the eligible candidates is 62 years. The tenure of the Member appointed will be Maximum of 5 years or till he attains the age of 65 years, which ever is earlier.
- 3) The person appointed would have to resign or opt for voluntary retirement from the service to which he or she belongs.

As per Andhra Pradesh Electricity Regulatory Commission (conditions of service of Chairman & Member) Rules 1999, the pay and allowances of the Chairman of the Commission shall not be inferior to the pay and allowances paid to Chief Justice of Andhra Pradesh High Court.

The Andhra Pradesh Electricity Regulatory Commission has been constituted in the month of April, 1999 with Chairman and two Members to regulate the electricity Industry in Andhra Pradesh to act in an efficient economic, safe and transparent manner. The term of one Member is completing on 13-08-2013, and it is decided to fill up the said post. The Selection Committee for this purpose has been constituted vide G.O.Ms.No.20, Energy Department Dt.06-03-2013 as per sub section (1) of section 4 of Andhra Pradesh Electricity Reform Act, 1998 read with Section 85 (1) of Electricity Act, 2003. It is decided to call for nominations from suitable persons for the post of Member of the A.P. Electricity Regulatory Commission. The nominee should be a person of ability, integrity and standing with adequate knowledge or experience of, or should have shown capacity in, dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management. The appointment would be made in accordance with the following -

- 1) The Member shall have Graduate qualification with specialization and adequate experience in any of the disciplines like Law, Economics, Commerce, Finance, Accountancy or Administration.
- 2) The minimum age limit for appointment is 55 years. Maximum age of the eligible candidates is 62 years. The tenure of the Member appointed will be Maximum of 5 years or till he attains the age of 65 years, which ever is earlier.
- 3) The person appointed would have to resign or opt for voluntary retirement from the service to which he or she belongs, if he holds any office under the State or Central Government or public sector corporation or any Government body.

As per Andhra Pradesh Electricity Regulatory Commission (Conditions of service of Chairman & Member) Rules 1999, the pay and allowances of the Chairman of the Commission shall not be inferior to the pay and allowance paid to Chief Justice of Andhra Pradesh High Court.
