Sir/Madam,

This is regarding deputation of Indian Civil Service Officers to Afghanistan, under the National Institute Building Programme (NIBP) of the United Nations Development Programme (UNDP), for continuing Indian assistance in Capacity Building of Afghan Government Institutions under a tripartite Memorandum of Understanding signed between the UNDP, Government of India (Ministry of External Affairs) and the Government of Afghanistan under the NIBP.

2. In this connection, the Ministry of External Affairs has intimated that the tripartite MoU between Government of India, Government of Afghanistan and the UNDP, Kabul, has not been renewed and at present the Project comes to an end on 31.12.2013. The MEA has, therefore, advised that the extension proposal of Indian Officers working as CDA in the NIBP Project, Kabul may be considered only till December, 2013.

3. Keeping in view the above, the State Governments/Cadre Controlling Authorities are hereby advised that any extension proposal on the above project be restricted to 31.12.2013.
