

Dear Chief Secretary,

I would like to draw your kind attention to Shri Ajit Seth, Cabinet Secretary's D.O. letter No. 13045/16/2013-Acad.Desk dated 8th April, 2013 (copy enclosed) emphasizing the need for identifying and nominating willing and suitable IAS officers working in the State Government for posting as faculty members in the Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie.

2. With the introduction of Mid-career Training Programme (MCTP) for IAS officers in LBSNAA, Mussoorie, the activities of the Academy has increased manifold. Shortage of practitioner faculty in LBSNAA, Mussoorie critically impacts delivering of induction as well as professional courses. These positions typically require IAS officers of the level of Deputy Secretaries/Directors having first-hand experience of functioning in the District Administration, Zilla Parishads etc.

3. Presently, three posts of Deputy Director (Director level) in Pay Band-4 + Grade Pay of Rs.8700 and one post of Deputy Director (Jr.) (Under Secretary level) in Pay Band-3 + Grade Pay of Rs.6600 are vacant in the Academy. Further, two posts of Deputy Director (Director level) are likely to fall vacant in 2014. These posts are to be filled up on deputation basis under Central Staffing Scheme.

4. I shall be grateful if you could kindly arrange to get these vacancies circulated to all eligible IAS officers working in the State Government and also nominate willing and suitable IAS officers for posting as faculty members in the LBSNAA, Mussoorie under Central Staffing Scheme.

Dear Chief Secretary,

In recent years activities of the Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie have increased manifold with introduction of Mid-Career Training Programmes (MCTP) for IAS officers in LBSNAA but the faculty and staff position have not kept pace with these additional responsibilities. At present three posts of Deputy Director (Sr.), three posts of Deputy Director and one post of Deputy Director (Jr.) out of 15 posts of Deputy Directors under Central Staffing Scheme are vacant. These positions typically require IAS officers of the level of Deputy Secretaries/ Directors, who have first-hand experience of functioning in the District Administration, Zilla Parishads, etc.

2. You would appreciate that shortage of practitioner faculty in LBSNAA, critically impacts delivering of induction as well as professional courses. Hence, it is necessary to take remedial measures immediately. I therefore, request your personal attention to identify and nominate willing and suitable IAS officers working in the State Governments for posting as faculty members in the LBSNAA.
