VACANCY CIRCULAR

Subject: Appointment of Chairman, Tariff Authority for Major Ports (TAMP), Mumbai.

Applications are invited for the post of Chairman, Tariff Authority for Major Ports (TAMP), Mumbai.

2. The TAMP consists of a Chairman and two Members. The qualification and experience required for the post of Chairman as per Section 47A (4) (a) of the Major Port Trusts Act 1963 is as under:

"a Chairperson from amongst persons who is or who has been Secretary to the Government of India or has held any equivalent post in the Central Government and who has experience in the management and knowledge of the functioning of the ports."

3. The Chairperson shall hold office for a term of 5 years from the date on which he assumes charge or until the age of 65 years whichever is earlier. The terms and conditions of appointment of the officer selected shall be as per the rules and instructions of Central Government.

4. Candidates who are still in service may apply through proper channel. The Cadre Controlling Authority/the State Governments are requested to give wide publicity to the vacancy and forward names of suitable and willing officers for consideration for the post. The ACRs (only attested photocopies) of the officer in service for the last five years and clearance from administrative/vigilance angles and Integrity Certificate may also be sent.

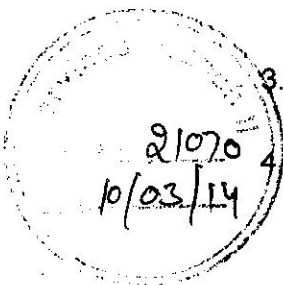
